Dress for Success Cincinnati received a grant from Impact 100, which helped the organization expand its unique services to outlying areas of Greater Cincinnati, as well as counties in Northern Kentucky, through a mobile suiting unit. This has allowed Dress for Success Cincinnati to serve women who have difficulty reaching the downtown location. The van also helps Dress for Success Cincinnati pick up donations that would have been lost due to the inconvenience of dropping them off downtown. Approximately 1,479 unduplicated clients were served in 2013. 1391 interview suits and 293 employment suits were distributed. There were 74 active Professional Women's Group members and 232 Career Center clients during the year. There were also 77 Going Places Network by Walmart program participants, and 44 of these members completed the program successfully
