The MCTC is housed in a custom-designed, commercial vehicle that accommodates wheeled racks of attire inventory, program materials, laptop computers, staff members, and volunteers. This has allowed Dress for Success Cincinnati to serve women who have difficulty reaching the downtown location. The vehicle also helps Dress for Success Cincinnati pick up donations that would have been lost due to the inconvenience of dropping them off downtown. Approximately 1,300 unduplicated clients were served in 2015. 1081 interview suits and 254 employment suits were distributed. There were 42 active Professional Women's Group members and 397 Career Center clients during the year. There were also 96 Going Places Network by Walmart program participants, and 76 of these members completed the program successfully by securing employment.
