The Career Center offers access to a professional human resources staff and volunteers, the Internet, computers, and printers to assist in resume preparation, job searches, effective self-promotion, and interview techniques. The Going Places Network (GPN) helps unemployed and underemployed clients gain career skills, utilize job search resources, and build confidence.
